



CHAMPAGNE AND AISHIHIK FIRST NATIONS

Dannch'e Parents/Guardians/Students of the Champagne and Aishihik First Nation,

The CAFN Education Department staff hope that you are all having a great Shakat (summer) and getting excited for Kets'adän Kų to start! I wanted to give all parents and guardians a heads up on some programs that are offered through CAFN.

School supplies funding:

All CAFN students attending a recognized Primary or Secondary school in **Canada** are eligible for school supplies funding. A form must be filled out in order to receive funds. Each student in Kindergarten – Grade 7 are allotted \$50.00 and students in Grade 8-12 are allotted \$65.00. Forms must be sent to Shauna Strand or Harold Risby at the Whitehorse CAFN office. Education Support workers will begin processing at the end of July and checks will be mailed out within 2-4 weeks. All checks are to be mailed from the Finance department and a full mailing address **MUST** be put in to the form in order for people to get their Dąnā (money).

**** Please note**** Only one parent “the sole care provider” of the child(ren) should apply for this fund. This helps reduce the paperwork and should be discussed by both parents as to who will receive the fund prior to submitting the application.

Tutoring funding:

Students living in Yukon are eligible for tutoring funding for \$80 per month. In exceptional circumstances, a student may be eligible for up to \$300 per month (This must be discussed with an Education Support Worker prior).

A request for tutoring form must be filled out **BEFORE** CAFN can assist with tutoring costs. Once a form has been filled out and given to the appropriate ESW then CAFN may begin to reimburse parents/guardians for the appropriate amount. CAFN will not do any direct billing for tutoring costs and all invoices are to be paid for up front then receipts brought to CAFN for reimbursement.

*****Tutoring services for a child with a DIAGNOSED learning disability are eligible to have those fees as a medical expense for taxes with the Canada Revenue Agency under their parent/guardian's taxes. A medical practitioner must certify in writing that these services are necessary*****
