This camp will provide our citizens the opportunity to participate in cultural land-based activities while sharing these connections with each other and guests. The intent is to assist our citizen's preserve their connections with Äshèyi, and landscape through culture, language and story.

Äshèyi Camp and Gathering will be based out of Äshèyi Shakat Ku Camp at the North End of Aishihik Road (61°38'19.61"N, 137°29'31.90"W)

All meals will be provided by CAFN.

ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER, AND INDEMNITY AGREEMENT

1.1 IMPORTANT NOTICE

By signing this document, you waive certain legal rights, including the right to sue. Please read carefully.

1.2 PARTICIPATION RISKS

I understand that participating in the Äshèyi Camp and Gathering (the "Event") from July 3rd to July 7th, 2026, involves inherent and other risks, that may result in serious injury, illness, property damage, or death, including but not limited to:

- (a) Natural hazards (e. g. , weather, terrain, wildlife).
- (b) Human-made hazards (e. g. , equipment, facilities).
- (c) Physical demands that may exceed my or my child's abilities.
- (d) Transportation to, from, and during the Event.
- (e) Actions or negligence of the Champagne and Aishihik First Nations Government, its representatives, or other participants.

I accept full responsibility for my and my child's participation in the Event and agree to take all necessary precautions to ensure safety.

1.3 RELEASE OF LIABILITY

In consideration of participation in the Event, I agree to:

- (a) Release the Champagne and Aishihik First Nations Government and its representatives from any liability for injury, death, property damage, or loss arising from participation in the Event, including negligence.
- (b) Waive any claims I or my child may have now or in the future against the Champagne and Aishihik First Nations Government and its representatives.

1.4 INDEMNITY

I agree to indemnify and hold harmless the Champagne and Aishihik First Nations Government and its representatives from any claims, damages, or expenses arising from my or my child's participation in the Event, including claims by third parties.

1.5 ACKNOWLEDGEMENTS

I confirm that:

- (a) I have read and understood this Agreement.
- (b) I am aware of the risks involved and accept full responsibility for my or my child's safety.
- (c) My child and I are physically capable of participating in the Event.
- (d) This Agreement is binding on me, my child, and our heirs, executors, and representatives.

1.6 GOVERNING LAW

This Agreement is governed by the laws of the Yukon Territory, and/or Champagne and Aishihik First Nations.
