The goal of this Youth 1st is to provide our youth the opportunity to participate in cultural land based activities while introducing them to the land and its attributes. The intent is to assist our youth to preserve the subsistence lifestyle, wilderness navigation, while learning both traditional and contemporary methods of harvest and learning from our experienced traditional harvesters.

Youth 1st Hunt Camp will be held in the Alsek Valley, 2 hours West of Haines Junction. Road access to the Alsek Valley is located at the end of the Bear Creek Subdivision. (It will take approximately 1 hour by quad or truck to access the Camp Location.

Registration is important in order to know how many will be attending; this will provide the details needed to prepare for adequate camping supplies and meal planning.

Please bring your camping gear, all appropriate clothing for the week and your potlatch bag

Clothing (cold weather travel):

Do not bring the following items to camp:

- Valuables
- Any non-prescription illegal drugs
- Any electronics (iPod, Mp3, video games, tablets etc.)
- Alcohol
- Weapons

Hunting:

- Headlamp/flashlight
- Binoculars
- Day pack
- Skinning knife
- Belt / Leatherman (in case)
- Sharpening stone
- Jacket for skinning (may get stained)

**** Please try to avoid bringing cotton clothing as these take a long time to dry. We recommend bringing poly blends, wool and other synthetic clothing. When packing your clothing remember that some of your clothes may be torn or wrecked, while in the bush. ****

- Personal & Allergy Medication
- Sunglasses
- Towel (fast drying)
- Thermos for hot drinks
- Water bottle (heavy duty, no glass)

- Sandwich container that will not leak (Tupperware style containers are best)
- Plate/bowl/cutlery (camping style)
- Book and Playing cards (optional)
- Tent (if you have one)

ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER, AND INDEMNITY AGREEMENT

1.1 IMPORTANT NOTICE

By signing this document, you waive certain legal rights, including the right to sue. Please read carefully.

1.2 PARTICIPATION RISKS

I understand that participating in the Youth 1st Hunt Camp (the "Event") from September 21st-25th, involves inherent and other risks, that may result in serious injury, illness, property damage, or death, including but not limited to:

- (a) Natural hazards (e.g., weather, terrain, wildlife).
- (b) Human-made hazards (e.g., equipment, facilities).
- (c) Physical demands that may exceed my or my child's abilities.
- (d) Transportation to, from, and during the Event.
- (e) Actions or negligence of the Champagne and Aishihik First Nations Government, its representatives, or other participants.

I accept full responsibility for my and my child's participation in the Event and agree to take all necessary precautions to ensure safety.

1.3 RELEASE OF LIABILITY

In consideration of participation in the Event, I agree to:

- (a) Release the Champagne and Aishihik First Nations Government and its representatives from any liability for injury, death, property damage, or loss arising from participation in the Event, including negligence.
- (b) Waive any claims I or my child may have now or in the future against the Champagne and Aishihik First Nations Government and its representatives.

1.4 INDEMNITY

I agree to indemnify and hold harmless the Champagne and Aishihik First Nations Government and its representatives from any claims, damages, or expenses arising from my or my child's participation in the Event, including claims by third parties.

1.5 ACKNOWLEDGEMENTS

I confirm that:

- (a) I have read and understood this Agreement.
- (b) I am aware of the risks involved and accept full responsibility for my or my child's safety.
- (c) My child and I are physically capable of participating in the Event.
